STEP FIVE: Declaration

I, the aforementioned person applying for Fiji Swimming membership, declare as follows:

1. It is a requirement that members who work, coach, supervise or have regular unsupervised contact with people under the age of 18 years give the following declaration;
 - a. I do not have any criminal charge pending before the courts
 - b. I do not have any criminal convictions or findings of guilt for sexual offences, offences related to children or acts of violence.
 - c. I have not had any disciplinary proceedings brought against me by an employer, sporting organisation or similar body involving child abuse, sexual misconduct or harassment, other forms of harassment or acts of violence.
 - d. I am not currently serving a sanction for anti-doping rule violation under a FASANOC approved anti-doping policy applicable to me.
 - e. I will not participate in, facilitate or encourage any practice prohibited by the World Anti-Doping Agency Code or any other FASANOC approved anti-doping policy applicable to me.
 - f. I will at all times comply with working with children legislative requirements that may apply to me.
 - g. I will notify Fiji Swimming immediately on becoming aware that any of the matters set out in the above paragraph have changed.
2. Personal Information Consent: Fiji Swimming may collect personal information about its members from various sources. In order to properly conduct its operations and fulfil its objects, FS may need to store, use and disclose that personal information – for example, FS will disclose each members personal details to FASANOC and the Ministry of Education, so they can keep a register of its members.
 - a. The information provided by me in this membership application form is true and correct.
 - b. I consent to the collection, storage, use and disclosure of my personal information by FS for administration and disciplinary purposes, including for the purpose of assessing my membership application (current & future), and for promotional, marketing, publicity, research and profiling purposes.
